



ANOTHER NEW KILLING FIELDS PROPOSED:

DOCTORS ARE REQUESTED TO KILL THE PATIENT IF HE/SHE HAS GOT A TERMINAL ILLNESS AND 1 YEAR TO LIVE(?) ; FOLLOWING HIS/HER REQUEST TO END HIS/HER LIFE ,THE DOCTOR GIVES THE PATIENT: THE POISON FOR THE KILLING OF THE PATIENT(ASSISTED SUICIDE) ???

The Islamic Medical Association and the two million British Muslims, will strongly oppose the "KILLING/DEATH" proposal by Lord Falconer and his self styled Commission on Assisted suicide, which has 9 out of its 11 members, believe and campaign strongly for the legalisation of Euthanasia and Assisted suicide, with funds from the pro-euthanasia supporters.

No doubt, this campaign is a devious long term plan to undermine the legal, medical and social protection of the right to life of vulnerable people;

Already we have and since more than 40 years: daily massacre or KILLING FIELDS:

Killing directly 600 innocent unborn babies, through ABORTION every day!

And now this CULTURE OF DEATH is trying to expand more ... in order to facilitate , through doctors again unfortunately , the killing of more vulnerable weak old and disabled patients.

It is incorrect to say Assisted Dying? It is in fact Assisted Killing because death/dying are supposed to occur normally naturally and suddenly as ordered by GOD, without the use of any "weapon" to kill and without the interference or help of any body :like the the doctor in this case.

It is in fact: suicide and assisted suicide and both: the patient and the doctor are guilty of the crime of killing.

THE FACTS ARE:

-No one can predict for sure when the patient will die within one year? We have a lot of recorded medical cases who stayed alive for years, after the medical verdict by doctors that they are going to die soon...!

-Some patients suffer from MASKED/DEEP DEPRESSION, which is difficult to diagnose sometimes

And one of the classical sign of depression is feeling suicidal hence the request for assisted suicide as a symptom? one should treat and "kill" the depression and not the patient.

-Safety measures are very difficult to enforce, and always the vulnerable and weak old patients will be pressurised to be killed:

Right to die will become: DUTY TO DIE?

-Proper and more expanding Palliative Care facilities are needed today as they can take away a lot of pain and suffering (so much medical progress in having effective Analgesics today), especially when the patient feels WANTED AND LOVED (again "Kill" the pain not the patient)

And that it is our duty is to take care of him/her when is weak, old, disabled or ill.

-The unnecessary feeling of being A BURDEN on: the family, the hospital/NHS....

This is very serious "malformation" and important issue to address.

No doubt changes in attitudes are needed today, especially by members of the family:

Every patient should feel WANTED AND LOVED by the family/extended family first and by the doctors and nurses and all society second...

ALLOW US TO STATE NOW FEW BASIC RELIGIOUS FACTS (Islamic and many of these are Christians too) which give us many reasons to oppose Assisted suicide or any type of Euthanasia:

-Human life is **SACRED** and only our Creator who is the Owner of every human life has exclusively the right to end it (Natural death).

He is the only One who can decide about the end of the life of every one of us: not the patient, not the doctor, not the MP and not the judge

or Lord Falconer?

It is BLASPHEMOUS for any one to decide and take the steps to end his/her life.

People who deliberately end their own lives are engaging in ultimate rejection of God and his mercy.

This why: Attempted suicide, Assisted suicide, Euthanaia and abortion are all forbidden

-We believe GOD can **HEAL** any illness, GOD is the Healer forever....

(Our beloved Jesus: peace be upon hm, was a known healer for many medical illnesses during his life time, as stated in the final holy Book AL QUR'AN).

-**Meditation/Prayer** has been found in medical studies especially recently to take away the pain and depression too.

-For every disease there is **a cure**, as stated before by the final prophet Muhammad (peace be upon him): HOPE THERAPY.
