### **URGENT REQUEST TO ALL MUSLIM PARENTS**

#### **ANSWER THE GOVERNMENT'S PUBLIC CONSULTATION ON : THE PROTECTION OF CHILDREN ONLINE**

The Government/Department of Education , has launched a **Public consultation** into the best ways of protecting children online(internet/computer). This could see websites containing **Pornography or PORN(all types of sexual immorality in sexual films:adultery,promiscuity, sex with a person of the same sex , sex with many partners ,sex with prostitutes, anal intercourse,rape,sex with children,sexual violence, sexual crimes etc...???)**(about 20 forbidden acts/MUHARRAMAT), which all can be seen by our innocent children when they are sitting alone or in their rooms, on the computers/Laptops or when sitting on the computers in their friends's houses, or in internet cafe,or on mobile phones etc... and they can see also other harmful materials such as violence, self-harm and suicide sites,gambling,drugs,alcohol... which all are easily seen by all the children(& adults) at the moment on the computers/internet/websites???

**WE ALL SHOULD DEMAND IN THE CONSULTATION TO AUTOMATICALLY BLOCK,AT LEAST , ALL SEXUAL/PORN WEBSITES ,which are provided now by Internet Service Providers(ISP) ,like:**

**Virgin,BT,Sky...unless adult users opt-in( by direct voluntary request from the internet companies in order to be allowed to see the ADULTS sexual films and not to block it).**

Ministers have opened a consultation to seek the views of the public/Muslims/Parents and they are keen to hear how **YOU** think ? and how children and young people can best be protected from harmful online content.

The recent Independent Parliamentary Inquiry into Online Child Protection found that children are **easily accessing internet pornography** as well as other websites showing extreme violence or promoting self-harm and anorexia.

The horrifying figures are:

- One in three British ten year olds has been exposed to online pornography
- 81% of 14-16 year olds look at online porn at home
- 75% of teenagers say their parents have never talked about porn with them (1)
- Today we have a big problem in our society:The **SEXUALISATION OF OUR SMALL CHILDREN**,especially small girls.

However, about 39%( or less) of parents block or filter websites for their children, which means that harmful, shocking and degrading pornographic material is the default option in British homes. Furthermore, the convergence of internet enabled televisions and the rise in web-enabled games consoles, players, phones and tablet computers has made device level filters redundant. (2)

The Government has launched **a consultation** to gauge opinion on the best way to protect children from harmful online material.
